In case any Duty Magistrate proceeds on station leave, he/she shall make alternative arrangement himself/herself with some other judicial officer under intimation to the undersigned.

2.	In case any of the Officer on duty happens to proceed on leave due to some emergency, then the duty work during Court hours shall be attended by the Duty Magistrate.
3.	As conveyed by the Registrar General, Hon'ble Punjab & Haryana High Court, through letter No.42423/Gaz.II(17) dated 28.10.2010, the Area Magistrates shall strictly attend to all kinds of matters i.e. the remand matters, receiving of special reports, production of case property etc., relating to the area of jurisdiction falling in the police station allotted to them, even beyond Court hours, on all working days, if they are at station.
4.	All the SHOs are directed to send the special reports in the Courts of respective Area Magistrates and if Learned Area Magistrate happens to be on leave or not available due to any other reason, then the same shall be submitted in the Court of learned Duty Magistrate.
5.	In case, any Officer on duty at Gurugram, Sohna & Pataudi has to proceed on station leave on any holiday and after Court-hours on any working day, then he/she, himself/herself shall make arrangement for duty with any other Officer, under intimation to the learned District & Sessions Judge, Gurugram as well as the undersigned.
	If any Officer (on duty) proceeds on training, on any working day/ holiday or on medical leave or earned leave etc. then the duty work in his/ her absence shall be attended to by the next Duty Magistrate. In such a case, the Duty Magistrate concerned will intimate the next Officer on duty, under intimation to the learned District & Sessions Judge, Gurugram as well as the undersigned.
The second second	Whenever, the Presiding Officers at Sohna & Pataudi shall be on leave or training or station leave the duty work of Sohna & Pataudi shall be attended to by the Duty Magistrate at Gurugram.
5.	In case any of the Officer on leave or not available due to any other reason, then statement u/s 164 Cr.P.C recorded in the Court of learned Duty Magistrate.
7.	The Duty Hours shall start from 10 A.M. to 9.59 A.M. (on the next date) during holidays and otherwise, after Court hours till the Court hour of the next date.
