  above.
- In case of exigency, if any Judge on duty would be on leave or otherwise, the other Judge on duty shall entertain all the matters of Civil and Criminal nature on that day.
- 3. As per instructions of the Hon'ble High Court contained in Notification dated 18.12.2023, no Judicial Officer will be allowed to prefix or suffix any casual leave with the winter spell / holidays i.e. from 25.12.2024 to 31.12.2024 and 01.01.2025.

- 4. Judicial Officers performing duty during winter spell shall be allowed to avail special compensatory casual leave upto June, 2025, as per the instructions of Hon'ble High Court issued on the subject. The Officers who would perform duty on prefix holiday i.e. 25.12.2024 and suffix holiday i.e. 01.01.2025 continuing with the winter spell shall not be entitled for special compensatory leave for these days.
- 5. The Protection Petition shall be dealt with by the Senior most Judge on duty.
- Any urgent matter of Civil and Criminal nature instituted during the win-6. ter spell shall be put up before the undersigned, on the 1st working day after winter spell, for proper assignment.
- 7. The official correspondence/Pay/TA/Contingency bills etc. of the office of undersigned shall be entertained/signed by the Senior most Judge on duty, during the aforesaid winter spell/holidays.
