- In case of non-availability of Principal Magistrate and Members of Juvenile 5. Justice Board, Gurugram, Shri Vishal, Judicial Magistrate on duty, shall deal with the urgent matters pertaining to Juvenile Justice Board, Gurugram.
- Protocol duty if any, shall be performed by the Senior most magistrate on 6. duty.
