ORDER

Pursuant to the directions contained in Office Order No. R-305/RG/DHC/2020 dated 21<sup>st</sup> May 2020 of Hon'ble High Court of Delhi vide which it is informed that

"Pursuant to Order No.40-3/2020-DM-1(A) dated 17.05.2020 issued by the Government of India regarding continuance of nationwide lockdown upto 31.05.2020, and in continuation of Hon'ble High Court's Office orders No.373/Estt./E1/DHC dated 23.03.2020, No.159/RG/DHC/2020 dated 25.03.2020 and No.R-77/RG/DHC/2020 dated 15.04.2020, No. R-159/RG/DHC/2020 dated 02.05.2020 and R-235/RG/DHC/2020 dated 16.05.2020, Hon'ble the Administrative and General Supervision Committee of Hon'ble High Court of Delhi has been pleased to order that the functioning of the Courts subordinate to Hon'ble High Court of Delhi shall continue to remain suspended till 31.05.2020 on same terms and also ordered that the matters listed from 26<sup>th</sup> May 2020 to 30<sup>th</sup> May 2020 in the subordinate courts be adjourned en bloc.
