ORDER**

Pursuant to the directions contained in Office Order No. R-235/RG/DHC/2020 dated 16th May 2020 of Hon'ble High Court of Delhi vide which it is informed that

"Hon'ble Administrative and General Supervision Committee while considering further extension of suspended functioning of Hon'ble High Court of Delhi and the Courts Subordinate to Hon'ble High Court of Delhi and taking note of the prevalent situation, in continuation of Hon'ble High Court's Office Orders No. 373/Estt./E1/DHC dated 23.03.2020, No. 159/RG/DHC/2020 dated 25.03.2020 and No. R-77/RG/DHC/2020 dated 15.04.2020 and No. R-159/RG/DHC/2020 dated 02.05.2020, has been pleased to order that the functioning of the Courts Subordinate to Delhi High Court shall continue to remain suspended till 23rd May 2020 and also ordered that the matters except the matters ready for final arguments (preference will be given to the cases which are more than 10 years old and cases where accused is in judicial custody/the matters pending in the MM (Mahila Courts) in which interim urgent relief has been sought under the Protection of Women from Domestic Violence Act, 1985/the matters pending in the court of Rent Controllers/Addl. Rent Controller in which application seeking leave to contest/defend is pending disposal in the cases filed on the ground of bonafide requirement} listed from 18th May 2020 to 23rd May 2020 in the subordinate courts be also adjourned en bloc."

accordingly, all the civil/criminal matters (except as mentioned above) pertaining to North District are adjourned en-bloc for the next date of hearing as per the table below :-
