## **ORDER**

In compliance of the directions contained in order no. R-235/RG/DHC/2020 dated 16.05.2020 of Hon'ble High Court of Delhi, all the cases <u>listed from 18<sup>th</sup> May 2020 to 23<sup>rd</sup> May 2020 in North & North-West District, Rohini Courts, Delhi have been adjourned enbloc vide order dated 16420-468F2(9)/Judl./COVID/NW/RC/2020 dated 16<sup>th</sup> May 2020 and 16572-619 F2(9)/Judl./COVID/North/RC/2020 dated 16<sup>th</sup> May 2020 respectively. It is directed that:-</u>

- 1. All the courts to prepone and take up the matters ready for final arguments, giving preference to more than 10 years old cases and cases where the accused is in judicial custody. MM (Mahila Court) shall take up matters in which interim urgent relief has been sought under the Protection of Women from Domestic Violence Act, 1995. Rent Controller/ Addl. Rent Controller shall take up matters in which application seeking leave to contest/defend is pending disposal, in cases filed on the ground of bonafide requirement.
- 2. Time and date of hearing shall be scheduled by the Reader/Ahlmad of the court, after speaking to counsels of both the parties and getting their written consent by way of an SMS, Whatsapp Message or E-mail.
- 3. All such matters shall be taken up through video conferencing only, using 'CISCO WEBEX' platform. The counsels for both the sides be impressed upon to send brief written submissions through independent e-mail ID of the respective court to be created with assistance of Computer Branch, Rohini Courts/Centralized Computer Committee.
- 4. No adverse order shall be passed without giving hearing through video conferencing or without having sought written submissions from the concerned counsel. In case any Judicial Officer wants to pronounce the judgement in physical presence of parties, all the necessary precaution for maintaining social distancing shall be ensured.
- 5. A schedule of such pronouncement be sent to the Branch Incharge, Judicial Branch of their respective district i.e. Sh. G.K. Mathur (Mob. 9911151311) for North-West District & Sh. Harish Chand (Mob. 9911212726, 9354386480) for North District by way of WhatsApp/ text message atleast two days before the scheduled pronouncement, so that a roster may be prepared.
