

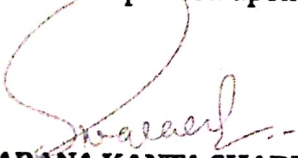

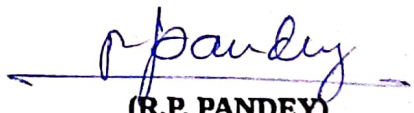
CIRCULAR

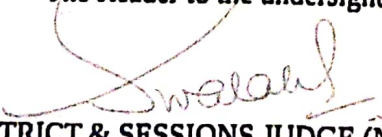

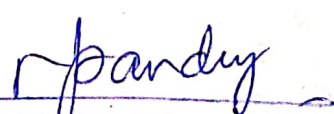
