

IMPORTANT NOTE:-

- Officer on duty in Group 1,2,3 shall look after daily work of Evening Court No. 1,2 and 3 respectively and shall adjourn the matters listed in the Evening Courts during regular court hours, i.e., between 10 AM to 5 PM as per their convenience.

- 2) Officer on duty in Group 2 Shall be the Duty MM for the day and shall be available at his/her residence after office hours.
- 3) Senior most Magistrate on duty shall exercise power of CMM.
- 4) No Magistrate or staff posted in any Court not on duty on any day shall leave their station of duty without prior permission of learned District and Sessions Judge, North District and they would be always be available on call and would be deemed to be on duty, in case of any urgency the undersigned may call upon them to report back for duty immediately.
- 5) The above named Judicial Officers shall hold the court in their respective court rooms, during the period mentioned against their name and shall be assisted by their own court staff and Officers are requested to issue necessary directions accordingly.
- 6) On the day when any Judicial Officer is not holding the court, their Reader/Ahmad/Asstt. Ahmad/ PA shall be present on rotational basis with their mutual consent & put the matter before the Judicial Officer mentioned at column No.3 and insure that the Kharza & Order sheet is updated on CIS on daily basis preferably by 11 AM and also ensure that any one Official shall be present in the concerned court during the working hours.
- 7) In case of any exigency, the CMM (North) shall be available at her residence in the entire afore-mentioned period.
- 8) Duty Magistrates on duty on Holiday/ Sundays shall remain unmodified during the afore mentioned period.
- 9) Non-presence of staff members in the courts personally, on any particular day be not treated as vacation.
- 10) The above matter has been prepared keeping in mind that all officers / MMs are in duty in Court / Jail for almost equal number of days.


