The Judicial Officer/Duty Judge shall be assisted by his/her own staff and inform their staff to remain present by that particular time.

The Judicial Officer available on the date mentioned against his/her name shall act as Chief Metropolitan Magistrate on that particular day and shall also look after the Administrative work of the North District and any correspondence with the Hon'ble High Court of Delhi shall be made only with the prior telephonic concurrence of the undersigned.
 4. The above named Judicial Officers shall hold the court in their respective court rooms during the aforesaid period and shall be assisted by their own court staff as per their requirement. Officers are requested to issue necessary directions to their staff accordingly.

It is further ordered that all the Judicial Officers posted in North District shall not leave the station under any circumstances and they shall always be available on call and would be deemed to be on duty. In case of any urgency the undersigned may call upon them to report back for duty immediately.
