
**ORDER**

**LINK ROSTER (Exclusively for Bail)**

In super-session of earlier Link Roster(exclusively for bail) No. Judl/Bail/North/RC/2020/7558-7582 dated 22.02.2020 and to streamline the work of bail applications in North District & to minimize the problems faced by advocates & litigants, it is hereby ordered that in case the Judicial Officer mentioned in Column No. 2 to whom bail applications of police station mentioned in Column No. 3 have been assigned happens to be on leave or not available due to any reason, the bail applications shall be placed before the Judicial Officer mentioned in Column No. 4 for disposal as per law and so on. If all the three Judicial Officers mentioned in Column No. 2, 4 & 5 happens to be leave or are not available due to any reason, the bail applications of concerned Judicial Officer shall be placed for disposal as per law before the Judicial Officer mentioned in S. No. 2 immediately below the S. No. 1 and in his absence, before the 1<sup>st</sup> Link Judicial Officer of that S. No. and so on and so forth. In case, the Judicial Officer mentioned in S. No.4 happens to be on leave or not available due to any reason, then the bail applications shall be placed before the Judicial Officer mentioned in S. No. 1 and so on and so forth. The said arrangement shall come into force with effect from 17<sup>th</sup> March 2020 till 31<sup>st</sup> March 2020:-
