

The National Judicial Academy (NJA) has scheduled the North Zone-II Regional Conference at Shimla, Himachal Pradesh on 21st & 22nd March 2020. In this regard I have also addressed a letter requesting your Lordship to nominate Hon'ble High Court Justices, Principal District Judges, Chief Judicial Magistrates and Registrars dealing with Recruitment Process and Budget preparation, for participation in the above conference.

Today (i.e. 11/03/2020), I have received a letter from the Registrar General of the High Court of Himachal Pradesh, Shimla intimating that the Chief Justice of the High Court requests NJA to cancel this Regional Conference scheduled on 21st & 22nd March, 2020 and to reschedule the same at a future date (Annexure-A).

The spread of "Covid-19" across several North Indian States and regions appears to be the basis for this request for cancellation.

In view of the above this is to inform that North Zone-II scheduled on 21st & 22nd March, 2020 is cancelled. In the event this programme is rescheduled during the current Academic Year, the Academy will intimate the same and request you for nominations afresh.
