#### Non-Receipt of record from RCBA 1.

The Committee has noted that Rohini Courts Bar Association (RCBA) while forwarding the list of members has not stated therein the date of their becoming members. This date is relevant for the reason that Clause 6A of the Constitution of RCBA entitles a person to vote if he has remained the member of RCBA for at least one year before the date of election. For want of this information, it is not possible to verify the Declaration Forms. Therefore, it is unanimously resolved that RCBA may be called upon to send aforesaid record/information immediately as the want of same is withholding yesup 15mm Marshar the scrutiny of the Declaration Forms.

# 2. <u>Infrastructure support for the Scrutiny of Declaration Forms of RCBA</u>

This Committee has been formed to scrutinize the Declaration Forms and to prepare the Voters' list of RCBA on the concept of 'one Bar one vote'. Our oral requests have been ignored.

It is unanimously resolved that a letter be sent to RCBA calling upon to set-up the requisite infrastructure to enable to scrutiny of the Declarations Forms.

# 3. Record of Elections of other Bar Associations/ Voters' List of Other Bar Associations

The Committee feels perturbed for the reasons that despite writing many letters and follow-up, records of the elections held by various Bar Associations have not been sent to us. Only, Delhi Bar Association (Tis Hazari Courts) has submitted the record in initially in print form and after consistent follow-up, the record in electronic form has been made available on Saturday i.e. 25.02.20217. This record of election of various Bar Associations is is necessary to scrutinize the Declarations Forms received in RCBA and for want of the same, the work cannot proceed further.

It has been unanimously resolved that let a reminder be sent to all concerned to immediate dispatch the record in print as well as in electronic form to enable us to begin the scrutiny of the Declarations
