4. No communication has been received from other District Judges/Bar Associations regarding our request to provide the list of voters for the last election conducted by the respective Bar Associations. Let a reminder be sent in this regard.



5. It is also resolved that Rohini Courts Bar Association be written a letter calling for :-

ii) A certificate that all the declarations furnished by the Members have been duly verified by the Rohini Courts Bar Association as to the correctness of the particulars contained therein.


iii) Information as to the cut-off-date beyond which a person despite being a Member, is not eligible to vote, as per the Constitution of Rohini Courts Bar Association.

iv) A declaration to the effect that the filing/acceptance of Declaration Forms was closed on 15.02.2017 with the close of the working hours of the RCBA.




