In case both the said Judicial Officers are on leave or not available due to similar reason, the Judicial Officer whose name is mentioned immediately below next in the table shall work as next Link Judicial Officer. In case Judicial Officer at Serial No. 3 mentioned in the above said table is happens to be on leave or busy in the Administrative work or is not available due to any reason his/her work shall be looked after by Judicial Officer mentioned at Serial No. 1 in the said table and so on and so forth. In case none of the Presiding Officers of Evening Court are available for any particular day due to any reason whatsoever, the work of the Evening Courts shall be looked after by the duty MM of that particular day.




