Sub: Duty Roster of Evening Courts w.e.f. 02.01.2023 to 31.01.2023.



In case Judicial Officer at Serial No. 3 mentioned in the above said table is happens to be on leave or busy in the Administrative work or is not available due to any reason his/her work shall be looked after by Judicial Officer mentioned at Serial No. 1 in the said table and so on and so forth. In case none of the Presiding Officers of Evening Court are available for any particular day due to any reason whatsoever, the work of the Evening Courts shall be looked after by the duty MM of that particular day.


