- 1. The Ld. Reliever MMs in Column A will look after the work of police stations mentioned in Column B.
- 2. The Ld. MMs (Reliever) of North-District shall perform their duties physically as they were performing earlier, i.e. TIP and recording of statement U/s 164 CrPC etc. on daily basis.
- 3. Ld. MMs (Reliever) shall also ensure that the statements u/s 164 Cr.P.C, are recorded on the same day unless for compelling reason (duly recorded in the order sheet), adjournment becomes imperative.
- 4. Whenever any Reliever MM in column No. C and column No.D is on leave or unavailable due to official work, his/her work shall be dealt with by the link Magistrate shown against his/her name in the opposite column. In case both the said Reliever MMs in Column C and column No.D are on leave or not available due to official work, the reliever MM whose name is mentioned immediately below the name of the unavailable Reliever MM shall work as his/her next Reliever MM. In case none of the Link Reliever MM named in the Column is available the work shall be dealt with by the Reliever MM named in the other column starting from the top.
- 5. Ld. MMs (Reliever) shall also remain available on call after working hours in the event of any contingency.
- 6. The Metropolitan Magistrates (Reliever) deputed as Metropolitan Magistrates (Reliever) shall not be allowed to avail leave on the day of their duty unless in case of extreme urgency or unavoidable circumstances. Metropolitan Magistrates (Reliever) may only be allowed to change their day of duties on mutual exchange basis with their Link MM (Reliever) well in advance. If the Metropolitan Magistrates (Reliever) is not available on any day of his/her duty due to some inevitable reasons, then his/her link mm (Reliever) shall perform the duty in his/her place.
- 7. It is impressed upon all Ld. Reliever MMs, not to fix any TIP before 2.00 pm and leave court premises without finishing daily routine work and also without giving due intimation to the undersigned.
