
Sub:-Duty roster of evening courts w.e.f. 01.03.2022 to 31.03.2022

In case Judicial Officer at Serial No. 3 mentioned in the above said table is happens to be on leave or busy in the Administrative work or is not available due to any reason his/her work shall be looked after by Judicial Officer mentioned at Serial No. 1 in the said table and so on & so forth. In case none of the Presiding Officers of Evening Court are available for a particular day due to any reason whatsoever, the work of the Evening Courts shall be looked after by the duty M.M. of that particular day.
