

- (1) The judicial officers shall maintain punctuality and strictly adhere to the Court timings.
- (2) The judicial officers shall fix sufficient number of cases every day so as to keep them substantially busy during the course of the day.
- (3) The judicial officers shall ensure that the VC links of their respective Courts remain functional/ open from 10.AM to 4.00 PM on every working day.
- (4) Wherever judgments have been reserved, the judicial officers shall pronounce the judgments within the time period stipulated in law and where no such period is stipulated, such judgements be pronounced as expeditiously as possible, but not later than 60 days from the date of conclusion of final arguments.
- (5) The judicial officers shall ensure that all orders and judgments are timely uploaded and all relevant data relating to cases is regularly updated on CIS.
- (6) The judicial officers shall take all requisite steps for expeditious disposal of 5 year old and 10 year old cases.
- (7) Wherever e-filing is mandated in terms of the E-filing Rules of the High Court of Delhi, 2021 the judicial officers shall ensure that the provisions in this respect are scrupulously complied with.

You are accordingly requested to impress upon all the judicial officers under your control to scrupulously comply with the aforesaid directions.
