### AMENDMENT

THE FOLLOWING SHALL BE INSERTED AS RULE 8A AFTER THE EXISTING RULE 8 OF PART A OF CHAPTER 3 OF VOLUME V OF THE DELHI HIGH COURT RULES & ORDERS :-

"8A. Party appearing in person — The Court may, in its discretion and after recording its brief reasons, disallow a party from appearing in person.

Provided, in such event the Court will give sufficient time to the party-inperson to be represented by a lawyer of the party's choice or where the party desires to be represented by an Amicus Curiae or legal aid counsel appointed by the Court."

"2(b) Every memorandum of appeal shall be accompanied by a copy of the judgment, as prescribed by Order XLI, Rule 1 of the Civil Procedure Code. In the case of Second Appeals, in addition to the documents prescribed by Order XLI, Rule 1 of the Code, memorandum shall be accompanied by a copy of the judgment of the Court of First instance unless the appellate Court dispenses therewith. In all cases which are within the competence of Division Bench motion. Duplication type written copies of memorandum of appeal or revision and other essential documents shall be furnished by the appellant or applicant, as the case may be, both in Civil and Criminal cases."
