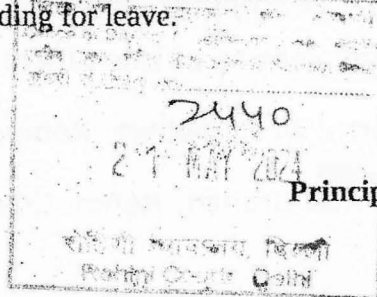
Subject: Reg. time bound action in Casual Leave software on LAYERS

It has been reported that during data analysis of the leave software, it has been observed that many Casual Leave Applications and Leave Intimations are lying idle at Forwarding and Sanction/Rejection stage.

The software has been designed to work as per individual's login, therefore, if the leave applications are kept lying in one's LAYERS login and he/she gets transferred, the working of the system is jeopardize and the leave process gets unreasonably delayed.

In order to streamline the very objective of automation of the casual leave system, it is impressed upon all the Ld. Judicial Officers, A.O. (Judl.), System Analysts, DDO, Branch Incharges, Accounts Officers to take action on their part preferably on the same day or latest by very next day of receipt of leave in their respective LAYERS login without fail.

It is further requested to all the Leave Sanctioning Authority to also adhere to the above timeline and must clear the pendency in their login of the leave software before transfer, relieving as Leave Sanctioning Authority or proceeding for leave.
