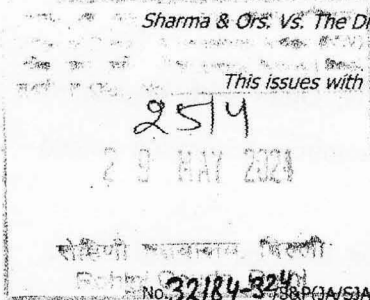
To Whomsoever It May Concern

The Seniority Committee in its meeting dated 07.05.2024 deliberated upon the objections received from the officials of 1992-Batch qua the tentative Seniority List of Senior Judicial Assistants circulated on 05.07.2023 wherein the affected officials amongst them raised objections viz. their initial "merit" at the time of their joining as LDC/JJA should be the basis of the seniority rather than "date of joining".

Thus, to give adequate opportunity of being heard, the Seniority Committee has directed to call upon all such affected officials of 1992-Batch to nominate/authorize a maximum of 05 officials (*i.e. 05 officials who are in favour of continuing with the extant provision of seniority list and 05 officials from the other group who would like the seniority list be drawn up on the basis of merit*) with consensus amongst themselves to represent each of their case before the Committee in its ensuing meeting. All such nominations/authorizations should reach this office within 05 working days of publishing of this notice/circular.

It must be noted that all such nominations/authorizations are invited exclusively from 1992-Batch and excluding from those officials whose cases have already been decided by the Seniority Committee in terms of the order dated 15.04.2024 passed by the Hon'ble High Court of Delhi in *WP (C) No. 5349/2024 titled as 'Hemant Sharma & Ors. vs. The District & Sessions Judge (HQs), Delhi.'*


