After due deliberations, the following decisions are unanimously taken:-

The format of Declaration form shall be in accordance with the mandate of judgment passed by Hon'ble High Court of Delhi in Writ Petition (Civil) No. 8106/2010 titled as P.K. Dash Adv. & Ors. vs. Bar Council of Delhi & Ors. and WP 10363/2021 titled as Lalit Sharma v. Union of India & Ors. and, therefore, the format of declaration form is hereby approved with the following instructions which is "Annexure A".

- 1. Each Declaration Form shall be numbered, on the top left side of the Form.
- 2. All the entries in the Declaration Form shall be clearly filled in with signature of member in blue colour ink. Incomplete form shall not be accepted/ summarily rejected.
- 3. The photograph should be original recent photograph of the Member in full Robes and not a computerized copy. Computerized photographs shall not be accepted and declaration form shall be summarily rejected. The photograph should be signed by the Member (preferably with the CD Marker/indelible ink) in such a manner that half of the signature appears in the form and the other other half appears in the photograph.
- 4. Attach a copy of ID card of RCBA or any other Bar Association.
- 5. Attach a copy of ID Card of BCD. (Attach copy).
- 6. Advocate calming voting rights on the basis of appearances shall furnish the copies of the 12 order sheets reflecting their name either as a lead counsel or as an Assisting counsel.
- 7. Only those Advocates are eligible to vote, who are enrolled in the RCBA till 31.07.2023 and are not in arrears of their subscription as on 31<sup>st</sup> July, 2024 (of the year of the election).
- 8. All the Advocates who are enrolled after 2011 shall submit the All India Bar Examination passing certificate. (Attach copy).

It has been brought to the notice of the Committee by the Members that acknowledgment/receiving of declaration form may be incorporated in the Declaration Form itself.

The issue has been considered and it has been unanimously decided that the acknowledgment/receiving of declaration form may be incorporated in the Declaration Form itself.

The schedule for the process is "Annexure B", which has been prepared in terms of directions issued in judgment passed in W.P. 10363/2021 titled as Lalit Sharma v. Union of India & Ors.

The RCBA office shall inform the number of Declaration Forms received each day by 11:00 am on the next succeeding day.

The Declaration Form shall be collected and consolidated in a bunch of 150 each and be submitted by RCBA to the office of Election Committee.

The computer entry of each form should be made by the RCBA in an excel sheet and should be submitted in both hard and soft copy (pen drive).

The tentative as well as the final list shall be displayed on the website by the computer branch by creating necessary links.

The Objection forms as prepared during last election, i.e. "Annexure C" shall remain the same, which be made available by the RCBA, and be consolidated day wise and submitted by RCBA to the office of Election Committee accordingly.

The Nodal Officer is directed to send a written communication to the Rohini Court Bar Association to provide a list of eligible voters (in soft copy Excel and PDF format) for the RCBA Elections – 2024.
