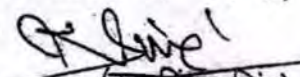

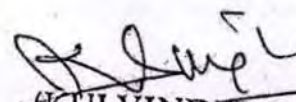
NOTIFICATION

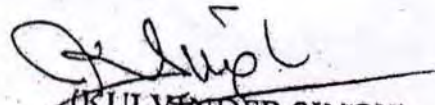
