



The above named Nodal Officer is further directed to check and verify the uploaded data on the above portal every Month.



The aforesaid Department has further created login ID & password for the High Court of Delhi, the details of which are as under:

In this regard, I am directed to state that apart from data pertaining to Commercial Courts already being uploaded by your good office on the portal of Department of the Justice, Ministry of Law & Justice, Govt. of India and the website of Delhi District Courts, it is also required to be uploaded on the aforesaid portal of Dept. of Legal Affairs Ministry of Law & Justice, Govt. of India. Therefore, I am directed to request you to:

- 1) Upload the Data pertaining to all the Commercial Courts across Delhi on the aforesaid portal of Dept. of Legal Affairs, Ministry of Law & Justice, Govt. of India (Annually from the inception till the year 2023 and monthly from January, 2024 onwards) and;
- 2). Nominate a responsible officer for this task who shall share a copy of the uploaded data to this Court upto June, 2024 latest by 15<sup>th</sup> July and subsequently monthly by 7<sup>th</sup> of every month.
