
**MINUTES OF MEETING**

It has been reported by the Nodal Officer that the work of scrutiny of declaration forms is being done as per the judgment i.e. ***Writ Petition (Civil) No. 8106/2010 titled as P.K. Dash Adv. & Ors. vs. Bar Council of Delhi & Ors. and WP (C) 10363/2021 titled as Lalit Sharma & Ors. v. Union of India & Ors.***

The Members has suggested that the Committee should call the list from the BCD the members who are debarred/suspended from the practice, in order to cross verify the final list of eligible voters of RCBA.

The members have also suggested that a notice may be circulated to the Members of the RCBA for voluntary withdrawal of the declaration forms, in case any member has annexed any / some fabricated documents along with their declaration forms, in order to get counted in the list of eligible voters. They have also suggested that an opportunity for voluntary withdrawal of such declaration forms may be given to the Members of RCBA.

In view thereof, it has unanimously decided that a notice to this effect be issued and same be circulated to the President/Hony. Secretary, RCBA for displaying the same in the notice board of the RCBA.




