It has been brought to the notice of the Committee that some members have submitted the supporting documents along with the declaration form which are not genuine or authenticated with the intent to meet the eligibility criteria of a "bona fide Advocate" as mandated by the Hon'ble High Court of Delhi in **WP (C) 10363/2021 titled "Lalit Sharma & Ors. v. Union of India & Ors."**

Any such violations will be taken with the utmost seriousness and the Election Committee has resolved to recommend appropriate disciplinary action to the respective Bar Council, as it amounts to professional misconduct.

The election committee is providing an opportunity to the Members of the RCBA to review the authenticity of the documents they have submitted. If any member has any doubt regarding the genuineness of any of the documents attached to the declaration form, they may **withdraw their declaration form**.

In addition to the above, Members who wish to withdraw their declaration forms for any reason whatsoever, may do so by submitting a written request on or before 12<sup>th</sup> Day of August 2024.

No further opportunity to withdraw the declaration forms will be available after 12<sup>th</sup> of August 2024.




