

**C I R C U L A R**

Pursuant to Hon'ble High Court's letter No. 7805/DHC/Gaz/G-4/2023 dated 09.11.2023, a Circular bearing No.Bldg./Gaz/CD/54003-54803 dated 11.12.2023 was issued by this office, informing all the Judicial Officers that any request regarding allotment of Govt. accommodation on priority/out of turn basis, shall be routed only through the office of Principal District & Sessions Judge, (HQs).

It has been again observed by the Hon'ble High Court of Delhi, New Delhi that many Judicial Officers are still sending their such requests directly through their respective Principal District & Sessions Judge and not through the office of the Principal District & Sessions Judge (HQs), Delhi.

It is, therefore, once again impressed upon all the Judicial Officers, that any request regarding allotment of Govt. accommodation on priority/out of turn basis, shall be routed only through the office of Principal District & Sessions Judge (HQs), Tis Hazari Court, Delhi.
