- (1) To consider the letter received from RCBA w.r.to extension of time.
 - (2) To Consider the application of the Members in respect of dues.
 - (3) To consider the issue raised by Office with respect to objection of interpolation of ordersheets.

It has been reported by the Nodal Officer, that a letter dated 12.09.2024 has been received from the Hony. Secretary, RCBA requesting to extend the time period for removing the objections in provisional voter list-2024 of RCBA.

It has also been submitted that most of the members are unable to remove the objections in the declaration forms within the requisite time, on one pretext or the other, and the time given by this Committee may be extended for a week.

The Committee has gone through this issue.

The Committee is of the unanimous view that, keeping in view the facts mentioned in the letter, the last date for removing the objection is **extended for two more working days**, meaning thereby, that **the last date for removing the objections in the declaration form stands extended upto 18.09.2024**. Necessary intimation be sent to the Hony. Secretary for placing the same in the notice board of the RCBA.







Office has informed that, a letter has been received from Sh. Manish Kumar, Advocate Enrl. No. D/7397/2020, Mob. no. 9582818264 requesting that he was facing some technical issues at the time of making the online payment, and due to this reason the payment has been made by his associate. He has filed the bank details of his associate. It has been requested that his objection may be removed, and he may be permitted to vote in RCBA elections-2024.




Another letter has also been received from Sh. Pratap Singh Dahiya, Advocate Enrl. No. D/247/2009, wherein, it is submitted that his subscription dues were paid by his sister's son (bhanja) as he is not using any online transaction mode, and is not having any cheque book. It has been requested that his objection may be removed and he may be permitted to vote in RCBA elections-2024.

Committee has gone through the said letters.

The Committee, vide minutes of meeting dated 28.08.2024, has already given relaxation to the effect that the declaration forms, where dues/subscription is paid by immediate family member/blood relation shall be considered in the category of "**eligible voters**" subject to their furnishing proper documents in this regard. However, in both the abovesaid cases, the Members have failed to establish that the said payment has been done through their blood relatives. These applications are kept pending to be decided in the next meeting.

It is reported by the Nodal Officer that in the objections "interpolation in order sheets" the Members are coming and requesting to file the fresh order sheets, against the interpolated ordersheets.

The committee has considered the plea of such members, and is of the considered opinion that the members, who have made interpolations in the judicial order sheets were knowing fully well at the time of submission of declaration forms, that they have done wrongful act which may attract evil consequences against them. Thus, giving them a chance to change/file fresh order sheets would be condoning their wrongful acts, therefore it cannot be allowed. In view thereof, no such request of members to file fresh order sheets be entertained.




In the last meeting while considering the letter received from RCBA regarding withdrawal of declaration form of one member of RCBA Sh. Radhey Shyam Kaushik, it was resolved that either the President/Hony. Secretary to appear before the Committee in person with the copy of Constitution and apprise the Committee about the relevant rules so that it can be checked under which rules RCBA can withdraw the declaration form of a Member or they can submit a copy of the Constitution of RCBA, highlighting the relevant rules through some representative but none of the member of RCBA has appeared today nor the copy of constitution has been sent, therefore one more opportunity is granted to RCBA to do the needful as directed.



Minutes of the meeting be uploaded on the Website of Rohini Court, Delhi.


