The Judicial Magistrate First Class (Reliever) mentioned in column no. A shall look after the work of respective link duty of TIP, recording statement under section 164 Cr.P.C. besides administrative duties as per Hon'ble High Court of Delhi Order No. 38/DHC/Gaz/G-7/VI.E.2(a)/2024 Dated 25/10/24 of the courts mentioned in Table A & JMFC (Reliever) mentioned at Column no. B shall look after the above said work of courts mentioned at Table B.

Remarks :-

- 1. Ld. Judicial Magistrate First Class (Reliever) shall also ensure that the statements u/s 164 Cr.P.C, are recorded on the same day unless for compelling reason (duly recorded in the order sheet), adjournment becomes imperative.
- 2. Whenever any Reliever JMFC in column No. A and B is on leave or unavailable due to official work, his/her work shall be dealt with by the link Reliever Magistrate shown against his/her name in the opposite column. In case both the said Reliever JMFCs in Column A and B are on leave or not available due to official work, the work shall be dealt as per the Link Roaster.
- 3. Ld. JMFCs (Reliever) who are not coming to court for physical duty on a particular day, shall always be available on call and they may be asked to attend court work on urgent basis.
- 4. The Judicial Magistrate First Class (Reliever) deputed as Judicial Magistrate First Class (Reliever) shall not be allowed to avail leave on the day of their duty unless in cases of extreme urgency or unavoidable circumstances. Judicial Magistrate First Class (Reliever) may only be allowed to change their day of duties on mutual exchange basis with their Link JMFC (Reliever) well in advance. If the Judicial Magistrate First Class (Reliever) is not available on any day of his/her duty due to some inevitable reasons, then his/her link JMFC (Reliever) shall perform the duty in his/her place.

- 5. Application for recording of statement u/s 164 Cr.P.C. in non sexual offences cases & application for TIP accused and case property moved before the area JMFC shall be marked by him/her to the Link JMFC (Reliever) as per table mentioned above and if the concerned Link JMFC (Reliever) is on leave or not available, then Link roaster bearing no. 17447-477/2024/CMM/North/Rohini/Delhi Dated 16/05/24 be followed.
- 6. An application for recording of statements u/s 164 Cr. P.C. of prosecutrix/victim in Rape or any other sexual offences cases be placed directly before next Female Link JMFC skipping Male (JMFC) as the case may be as per Link roaster bearing no. 17447-477/2024/CMM/North/Rohini/Delhi Dated 16/05/24.
- 7. Application for recording of statement u/sec. 164 Cr.P.C. of any child/victim less than 18 years pertaining to POCSO Act will be marked by the undersigned in the absence or non availability of the undersigned, the same shall be marked by Ld. ACJM (North) District Delhi and in the absence of or non availability of both the same shall be marked by the duty JMFC of the day.
- 8. It is clarified that if one JMFC (Reliever) of North District is assigned a number of statements u/sec. 164 Cr.P.C. for recording and he is held up in recording statements u/sec. 164 Cr.P.C. whereas the another JMFC (Reliever) of North District Delhi to record the same, so that the witness are not kept waiting in the Court complex.
- 9. It is also clarified that in case of exigencies, the misc. work can be assigned to any of Ld. JMFC/JMFC (Reliever) North District Delhi for smooth functioning of Court of North District Delhi.

This is an interim arrangement pertaining to the allocation of work to JMFC (Reliever) North District Delhi, till further order.
