


All the Judicial Officers are hereby directed to adhere to the guidelines and compliance be made.

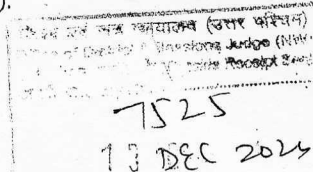


