In case both the said Judicial Officers are on leave or not available due to similar reason, the Judicial Officer whose name is mentioned immediately below next in the table shall work as next Link Judicial Officer. In case Judicial Officer at Serial No. 3 mentioned in the above said table, happens to be on leave or busy in Administrative work or is not available due to any reason, his/her work shall be looked after by the Judicial Officer mentioned at Serial No.-1 in the said table and so on and so forth. In case none of the Presiding Officer of Evening Court is available for any particular day due to any reason whatsoever, the work of the Evening Courts shall be looked after by the duty JMFC of that particular day.
