The nominated Judicial Officers may kindly be advised not to list any judicial work on **05<sup>th</sup> April, 2025 (Saturday)**, so that litigants and lawyers are not inconvenienced. In case some judicial work has already been listed, it may be postponed or adjourned accordingly, to the extent possible.
