## PRACTICE DIRECTIONS

Hon'ble the Chief Justice, on the recommendations of the Hon'ble "Rules Committee under Section 523 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (BNSS-2023) and all other criminal statutes and jurisdictions", has been pleased to issue the following practice directions for information and compliance by all concerned:

In order to obviate the possibility of any grievance being raised regarding the identification of the accused when the accused is produced through video conferencing, it is hereby directed that in all such cases where the identity of the accused is in dispute, the accused would be produced physically in court for the purpose of identification of the accused.

In all such cases, when the matter is fixed for evidence of the prosecution, the prosecution or the accused or the counsel for the accused may make an application before the concerned court that the identity of the accused is in dispute and he be produced physically for the purposes of his identification by the witnesses and the Court shall pass appropriate orders directing the production of the accused physically for the purpose of his identification by the relevant witnesses.

This Practice Direction shall come into force immediately.
