This meeting is called for security arrangements to be put in place for the forthcoming elections of Executive Committee of RCBA, Rohini scheduled to be held on 21.03.2025.






The DCP Rohini, has also prepared a site plan for election arrangements.

Gate no. 8 will be closed for all on 21.03.2025


Gate no. 9 will be open for Advocates only on 21.03.2025

Chowki Incharge, has also assured that the necessary security arrangements will be provided at room no. 503 from 19.03.2025 to 21.03.2025.


It is agreed by all the Members that the aforementioned plan of security arrangement would be followed with the help of concerned police officers.


