## ORDER

The urgent civil matters pertaining to Sub Division, Kalka, for the period from 01.06.2024 to 15.06.2024 shall be instituted before Sh. Upendra Singh, Addl. Civil Judge (Sr. Divn.), Kalka and from 16.06.2024 to 30.06.2024 before Dr. Jitender Kumar, Civil Judge (Jr. Divn.), Kalka.

All the urgent civil work instituted during vacation period before ACJ(SD)/CJ(JD) at Panchkula and CJ(JD) at Kalka shall be put up before Civil Judge (Senior Division), Panchkula and Addl. Civil Judge (Sr. Division), Kalka, as the case may be, for assignment, after the vacation.

The Chief Judicial Magistrate, Panchkula, shall prepare a roster of Judicial Magistrates for attending duty work from 01.06.2024 to 30.06.2024.

In case, the Judicial Officer at Sub-Division Kalka avails leave during the summer vacation, the Civil & Criminal work of Sub-Division Kalka shall be attended by the senior most Civil Judge and Duty Magistrate, respectively, at Panchkula.
