CIRCULAR

In view of the directions of the Hon'ble Supreme Court of India in Miscellaneous Application No. 890 of 2021 in Criminal Appeal Nos. 1375-1376 of 2013 titled "*Asian Resurfacing of Road Agency Pvt. Ltd. & Anr. Vs. Central Bureau of Investigation & Ors.*", please find annexed the list as "Annexure-A" pertaining to the Courts, New Delhi District, where stay has been granted. All the Ld. Judicial Officers, Patiala House Court, New Delhi District are requested to strictly comply with the directions as contained in para 35 of the aforementioned Order which reads as under and to proceed accordingly.

"35.....In cases where stay is granted in future, the same will end on expiry of six months from the date of such order unless similar extension is granted by a speaking order. The speaking order must show that the case was of such exceptional nature that continuing the stay was more important than having the trial finalized. The trial Court where order of stay of civil or criminal proceedings is produced, may fix a date not beyond six months of the order of stay so that on expiry of period of stay, proceedings can commence unless order of extension of stay is produced."
