**Sub: Coverage under CCS (Pension) Rules, 1972 in place of NPS for employees whose selection for appointment was finalized before 01.01.2004 but joined Government Service on or after 01.01.2004.**

It is informed to all the concerned that the eligible officials who were declared successful for recruitment in the results declared on or before 31.12.2003 against vacancies occurring before 01.01.2004 and are covered under the National Pension System on joining service on or after 01.01.2004 may submit one time option (proforma enclosed) to be covered under CCS (Pension) Rules, 1972, if intend to do so, as per the criterion laid down in the office Memorandum No. 57/04/2019-P&PW (B) dated 17<sup>th</sup> February, 2020 of Government of India, Department of Pension and PW.

The 'One Time Option' from the eligible officials, if any, in respect of the above may be submitted to the **DDO Sh. Amit Badoni** through office or at his email ([ddohq.thc@gmail.com](mailto:ddohq.thc@gmail.com)) latest by 31.05.2021. If no Option is received within the prescribed time limit till 31.05.2021, the official shall continue to be covered by the National Pension System. The option, once exercised shall be final. No option/communication/representation shall be entertained after the stipulated time in any condition.
