



CIRCULAR

It is impressed upon the Ld. Judicial Officers, New Delhi District, Patiala House Courts, New Delhi dealing with criminal jurisdictions that no Medical Practitioner/Doctor is summoned for recording of testimony before the Court in the pre-lunch session and summons be issued for their appearance at 02.00 PM onwards.

Further, if any Medical Practitioner/Doctor appears for recording of his/her evidence, priority be afforded to record their testimony and discharge them at the earliest. It is also impressed upon the Ld. Judicial Officers that sincere efforts be made for admission denial of documents concerning testimony of Medical Practitioners/Doctors; and they may be summoned and examined through video-conferencing, wherever possible/practicable.

Any infraction of these directions shall be viewed adversely.


