**ORDER**

In view of the alarming rise in the number of COVID-19 cases and its consequent toll on the health and lives of the judicial officers and staff of the District Judiciary in partial modification of the Court's earlier notifications No. 463/I-G-4/Genl.-I/DHC dated 17.10.2020 and No. 465/I-G-4/Genl.-I/DHC dated 17.10.2020, the Hon'ble Full Court has been pleased to prepone the Summer Vacation for the District Courts in Delhi for the year 2021 and order that the District Courts (except the Courts of Metropolitan Magistrates) in Delhi will remain closed for Summer Vacation from Monday, 17<sup>th</sup> May 2021 to Thursday, 3<sup>rd</sup> June 2021 (both days inclusive).

The period of 30 days from 17<sup>th</sup> May 2021 to 15<sup>th</sup> June 2021 is declared as vacation month/period for the year 2021 for the members of Delhi Judicial Service under the Delhi Judicial Service (Leave) Rules, 2011.

In continuation of this Court's Office Order No. 5/R/RG/DHC/2021, dated 23.04.2021 it is further ordered by the Hon'ble High Court of Delhi bearing reference no. 6/R/RG/DHC/2021 that the cases listed between Monday, 17<sup>th</sup> May 2021 to Thursday, 3<sup>rd</sup> June 2021 shall be taken up from Monday, 14<sup>th</sup> June 2021 to Wednesday, 30<sup>th</sup> June 2021 on the corresponding working days and the existing system of hearing the matters in the District Courts in Delhi shall continue up to 30.06.2021
