



**ORDER**

Hon'ble the Chief Justice and Hon'ble Judges of this Court have decided not to transfer the cases u/s 138 Negotiable Instruments Act involving "Financial Institutions" to Rouse Avenue Court Complex. **NOTES:-**

1. The judicial officers shall be under the control of the District & Sessions Judge of the District to which they have been allocated.
2. The judicial officers under transfer shall notify the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.



3. The Note Nos. 10, 11 and 12 as mentioned in the transfers/postings Order No. 12/DHC/Gaz/G-7/VI.E.2(a)/2019 dated 26<sup>th</sup> March, 2019 stand withdrawn.
4. The District & Sessions Judges shall assign sufficient number of cases to the newly created courts of MM (NI Act) in their respective districts on withdrawal from other such courts and general courts of Metropolitan Magistrates in order to ensure equitable distribution of workload.
5. In the transfers/postings order No.12/DHC/Gaz./G-7/VI.E.2(a)/2019 dated 26<sup>th</sup> March, 2019, in the Remarks Column at Sl. No.86 "PS Bhalswa Colony" be read as "PS Bhalswa Dairy" and "MM-4, North Rohini" be read as "MM-7, North, Rohini".


