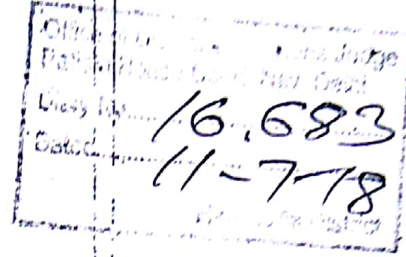

It is hereby notified for general information that Shri Nawal Kishore Kashyap, Advocate, Lawyers Association, Patna High Court (Bihar), Son of Shri Sheo Dayal Singh, who was enrolled as an Advocate by Bihar State Bar Council on 28.11.1996 vide Enrolment No. 10208/1996, has been debarred from practicing as an Advocate for a period of two years by Disciplinary Committee No. VII of Bihar State Bar Council by order dated 18.3.2018 passed in D.C. Enquiry No. 04/2017 on the basis of cognizance taken by the Special Committee of Bihar State Bar Council vide item no. 13/19.3.2017, Under Section 35(3)(c) of the Advocates Act, 1961. Thus Shri Nawal Kishore Kashyap, Advocate, Lawyers Association, Patna High Court is debarred from practicing as an Advocate in any Court or before any authority or person in India, from the date of this notification, for a period of two years.
