- (a) be responsible for regularly supervising the work of the Branches (and connected Branches and Sections) under their control on daily basis, inter alia, by providing necessary guidance/directions to the Administrative (Judl.) or Branch Incharge.
- (b) take all necessary decisions using proper discretion in matters of routine nature, keeping in mind the best interest of the institution and shall refer the matter to the District & Sessions Judge, in case of any doubt;
- (c) Co-ordinate with other Officer(s) -in-Charge and Committees, whenever required.
- 2. The Administrative Officer Judicial/ Branch Incharges and all subordinate staff shall work under the control and supervision of the concerned Officer Incharge. They will be answerable to and report on daily basis to the respective Officer(s) in-Charge.

- 5. The leave of AAO & AO (J) shall not be approved without prior intimation to District & Session Judge, NDD.
