



**ORDER**

Owing to logistics and administrative issues, Ld. Metropolitan Magistrates (NI Act Courts), at Rouse Avenue Courts Complex, which are under the administrative control of New Delhi District, are hereby directed to ensure that leave applications of the staff posted in such NI Act Courts at Rouse Avenue Courts Complex shall be diligently considered and be forwarded to this Court without any delay. The leave applications be allowed in a judicious manner so that judicial as well as administrative work is not hampered and sufficient staff strength remains available for smooth functioning of the Courts.

It is further provided that in case any Ld. Metropolitan Magistrate (NI Act) at Rouse Avenue Courts Complex is on leave, neither the Stenographer nor Peon shall report for duty at Patiala House Courts Complex and assignment of duties inter-se amongst the Ld. Metropolitan Magistrates (NI Act Courts) shall be in the discretion of the senior most Officer i.e. Ld. Metropolitan Magistrate (NI Act)-02, Rouse Avenue Courts Complex and in case, he is also on leave, such assignment work shall be taken-up by the next available Ld. Metropolitan Magistrate (NI Act), as per seniority.

It shall be ensured that the aforesaid directions are complied with scrupulously.


