- In compliance of the directions of the Hon'ble High Court of Delhi vide order No. 569/RG/DHC/2021 dated 19.08.2021, it is impressed upon the Additional Sessions Judge(s) who are holding the court physically on a given day to deal with fresh bail applications, in addition to their regular board, in those cases where investigation is pending and the counsel has made a specific request for hearing the matter in physical court. Such bail applications shall, as far as possible, be disposed of by the same roster judge.*
- In case the roster Judge is hearing the matter virtually on a particular day and the counsel has made a specific request for hearing, the matter in the physical court, such application shall be put before the first link Judge and in case of non availability of 1st link Judge.. In compliance of the directions as issued by the Hon'ble High Court of Delhi in order dated 19.08.2021, such transferred applications shall continue to be dealt with by the same Judge.*
