ORDER

In view of the alarming rise in the number of COVID-19 cases and its consequent toll on the health and lives of the judicial officers and staff of the District Judiciary in partial modification of Hon'ble Delhi High Court's earlier notifications No. 463/I-G-4/Genl.-I/DHC dated 17.10.2020 and No. 465/I-G-4/Genl.-I/DHC dated 17.10.2020, the Hon'ble Full Court has been pleased to prepone the Summer Vacation for the District Courts in Delhi for the year 2021 and order that the District Courts (except the Courts of Metropolitan Magistrates) in Delhi will remain closed for Summer Vacation from Monday, 17th May 2021 to Thursday, 3rd June 2021 (both days inclusive). The Courts of Metropolitan Magistrates are ordered to remain closed for Summer Vacation from 17.05.2021 to 27.05.2021 (both days inclusive).

In continuation of previous Office Order No. 5/R/RG/DHC/2021, dated 23.04.2021 it is further ordered by the Hon'ble High Court of Delhi bearing reference no. 6/R/RG/DHC/2021 that the cases listed between Monday, 17th May 2021 to Thursday, 3rd June 2021 shall be taken up from Monday, 14th June 2021 to Wednesday, 30th June 2021 on the
