
The office has informed that despite sending reminders, the following Court Complexes/Bar Associations have not submitted the voter's list till date :

The Committee desires that reminders be sent again to the above mentioned Court Complexes/Tribunal/Bar Associations to share their voter's list within 10 days.

The Committee has noted that Declaration Forms have not been received from the New Delhi Bar Association. Vide minutes of the meeting held on 29.11.2021, the committee has already extended the period for submission of Declaration Forms. Sh. Nagendra Kumar, Hony. Secretary, NDBA, has informed that only 1250 numbers of Declaration Forms have been received from advocates/members of NDBA till date. The advocates are still paying their dues and he has again requested for extension of date for payment of dues, so that the remaining members of the could submit their Declaration Forms.


The Committee considered the circumstances and has resolved that the date may be extended by 10.01.2022 without further extension. The Committee desires that the President and Hony. Secretary of NDBA again be requested to expedite the process of collecting Declaration Forms and submit to the committee for scrutiny and further action.




