**ORDER**

The Hon'ble High Court of Delhi has directed vide Order No.67/RG/DHC/2022 dated 11.02.2022 as under :

*In continuation of this Court's Office Order No.1/RG/DHC/2022 dated 12.01.2022 and as directed by the Hon'ble Full Court, all the Principal District and Sessions Judges and the Principal Judge, Family Court (HQs) shall prepare roster of judicial officers of their respective districts/Family Courts in such a manner that w.e.f. 14.02.2022, around 50% of the total strength of judicial officers hold the court physically while the others take up the matters through virtual mode.*

*The aforesaid arrangement shall continue up till 28.02.2022 and from 02.03.2022 there shall be complete resumption of physical hearings in the Delhi District Courts. After complete resumption of physical hearing, the Courts may, in exceptional circumstances on a case-to-case basis, permit hybrid/video-conferencing hearing.*

*The Advocates, staff officials, litigants and other visitors to the Courts shall follow all the Covid-19 protocols, guidelines, directions, etc. issued by the Govt. of India, Govt. of NCT of Delhi and Court administration from time to time.*

*All stakeholders be also advised to get themselves vaccinated at the earliest.*

In compliance of the aforementioned Order, the Judicial Officers, New Delhi District, mentioned at column No. 'A' will hold the court physically on the *Even* dates and the Judicial Officers mentioned at column No. 'B' will hold the court physically on the *Odd* dates with effect from 14.02.2022 till 28.02.2022 and from 02.03.2022, there shall be complete resumption of physical hearings. After complete resumption of physical hearing, the Courts may, in exceptional circumstances on a case-to-case basis, permit hybrid/video-conferencing hearing. The Judicial Officers who are not holding the Court(s) physically shall hold the Court(s) through video-conferencing.
