The roster of the staff so prepared be submitted before the Administrative Officer (Judl.) / Incharge – Administration, New Delhi District.

The officials posted in the respective Courts, New Delhi District are directed to perform their duties as per directions of the Ld. Presiding Officers for smooth functioning of the Courts. Ld. Presiding Officers shall also prepare a roster in a manner that either Reader/Ahlmad/Asstt. Ahlmad remain present on call on working days in the Courts to answer any query of the Lawyers/litigants.

It is impressed upon all the Ld. Presiding Officers/Ld. Officers-in-Incharges to exempt physical presence of Differently abled staff members as well as expecting female staff members posted in Courts/ Branches and they are directed to work from home.

It is impressed upon all the concerned to scrupulously adhere to the norms of social distancing, wearing of masks and regular hand-wash & all other Covid-19 related guidelines issued by the Government of India, Government of NCT of Delhi and Hon'ble High Court of Delhi from time to time.
