**ORDER**

Pursuant to the **Foot Note no. 3 & 4 in order No. 06/G-I/Gaz.IA/DHC/2022 dated 28<sup>th</sup> February, 2022** of the Hon'ble High Court of Delhi, New Delhi and in continuation to this office order No. 4819-4849/Judl./NDD/PHC/ND dated 05.03.2022, the Court of Additional Sessions Judge-06, New Delhi District shall be the **Successor Court** of the Court of Additional Sessions Judge-02, New Delhi District except the cases pertaining to under Section 22 of the National Investigation Agency Act, 2008, in terms of Notification No. F.1/1/2012-Judl./Suptlaw/1041-1045 dated 12.09.2013 issued by GNCTD and the cases under the Scheduled Caste and Scheduled Tribe (Prevention of Atrocities) Act, the Securities and Exchange Board of India Act as well as Sessions cases investigated by Special Cell, Delhi Police (other than those offences as mentioned in schedule of National Investigation Agency Act, 2008, which shall be triable by the court of ASJ-02, New Delhi District), **with immediate effect.**

Further, the Court of Additional Sessions Judge-07, New Delhi District shall be the **Successor Court** of the Court of Additional Sessions Judge-03, New Delhi District except the cases pertaining to Scheduled Offences investigated by the National Investigation Agency in terms of Office Memorandum No. 37/Legal/Spl.Court/Judge/NIA/Delhi-13082 dated 11.10.2019 as well as cases under Maharashtra Control of Organized Crime Act, 1989, **with immediate effect.**
