ORDER

Pursuant to the **Foot Note no. 3** in order No. **06/G-I/Gaz.IA/DHC/2022 dated 28th February, 2022** of the Hon'ble High Court of Delhi, New Delhi, all the pending cases [except the cases under section 22 of the National Investigation Agency Act, 2008, in terms of Notification No. F.1/1/2012-Judl./Suptlaw/1041-1045 of GNCT of Delhi dated 12.09.2013 and any connected case thereto, and all pending cases under the Unlawful Activities (Prevention) Act)], are hereby withdrawn from the Court of Dr. Hardeep Kaur, ASJ-02, New Delhi District and assigned to the Court of Ms. Kiran Gupta, ASJ-04, New Delhi District for disposal in accordance with law with immediate effect.
